

GBR CPE Credit Program - FAQ

CPE certification at Atlassian Team Tour: Government Symposium is being administered by Government Business Results, LLC.

Government Business Results, LLC is registered with the National Association of State Boards of Accountancy (NASBA) as a sponsor of continuing professional education on the National Registry of CPE Sponsors. State boards of accountancy have final authority on acceptance of individual courses for CPE credit. Concerns regarding registered sponsors may be submitted to the National Registry of CPE Sponsors through its website: www.nasbaregistry.org.

Q: Are all classes at Atlassian Team Tour: Government 2022 CPE certified?

All Atlassian Team Tour: Government 2022 classes are eligible for CPE credits. In order to receive CPE credits, you must attend at least three full sessions and participate in random checkpoints during each session. Attendees are welcome to attend as many unique sessions they would like, in order to maximize credits earned.

Training sessions are also eligible for CPE credits. In order to receive CPE credits, you must attend the training session in full and participate in random checkpoints during each training. Attendees are welcome to join all training sessions to maximize credits earned.

Q: Do I need to attend all sessions to receive credits?

A: No. You do not need to attend all sessions at Atlassian Team Tour: Government 2022 to receive credits. However, you must attend at least three sessions and participate in random checkpoints in order to receive CPE credits.

Q: Is there a separate registration process for the Atlassian Team Tour: Government 2022 CPE courses?

A: No, by registering with Atlassian Team Tour: Government 2022 you are eligible to receive CPE credits by attending the entire class group or training and participating in random checkpoints during each session (see groups above).

Q: Is there a cost for obtaining CPE credits for the Atlassian Team Tour: Government 2022 classes?

A: The classes are free of charge to those registered for Atlassian Team Tour: Government 2022.

Q: Are there any pre-work requirements to attend a CPE certified session?

A: No. There are no prerequisites or advanced preparation required for the courses.

Q: Do I need to bring anything to the session to obtain CPE credit?

A: No, there is nothing you need to bring to the sessions.

Q: How many CPE credits can I earn?

You can earn 1.0-10.0 CPE credits by attending sessions—the more sessions you attend, the more credits you can earn. Final credits will be dependent on total time spent in class/training, and confirmation of engagement with all check-in points.

Q: How do I receive my CPE credit?

A: After the completion of the session, attendees must fill out an application <u>here</u> to receive CPE credits. Once your attendance is verified, a copy of your certificate(s) will be emailed to you within 10 business days.
